DO CUSOs REALLY MAKE A DIFFERENCE?

Forming and operating a CUSO takes time and effort. CUSOs tend to help credit unions reduce costs and make revenue from other sources but are CUSOs really worth the effort? It is a legitimate question. How can we measure the effectiveness of CUSOs? Jay Johnson, Chief Collaboration Officer at Callahan & Associates and a NACUSO Director, Jack Antonini, NACUSO President and Guy Messick, NACUSO General Counsel wanted to measure a subset of credit unions that use CUSOs extensively and compare their performance to credit unions that tend not to use CUSOs extensively.

For the CUSO user group, we turned to the credit unions that use the services of the CUSO, CU*Answers. CU*Answers, Inc. was formed in 1970 as a core IT provider. It is structured as a cooperative non-profit corporation. There are 128 credit union owners serving 182 credit unions. Xtend is an affiliate CUSO that is owned by CU Answers and 82 credit unions. Xtend provides services to credit unions that include bookkeeping, mortgage loan support, disaster recovery, business continuity, strategic planning, call center (both incoming and outgoing), shared branching, forms exchange, member texting communications, core conversion support, call report preparation, and cooperative liquidity through loan participations and certificate of deposit sales. Vendor management is also provided through partnership with a third party. While some credit union owner/customers are over a billion dollars in assets, most customers are small and mid-sized credit unions, the very size that should derive the most benefit from collaboration.

CU*Answers pays dividends to the owners. As a Michigan cooperative, CU*Answers pays a stock dividend each year (averaging between 4% and 8% of the investment for each credit union). There is a patronage dividend which is proportionate to the amount of business a credit union does with the CUSO. If CU*Answers has a special project and needs capital, it will issue debentures which have a return slightly above market. The debentures are often over-subscribed.

The control group consists of credit unions that are the same asset size as the CU*Answers group and do not have a CUSO investment. While the available data does not indicate how many CUSOs a credit union may use for services, it is possible to see from the call reports whether a credit union has a CUSO investment. If a credit union does not have any CUSO investment, it is more likely than not that the credit union does not use CUSO's extensively for services. It is certain that the group does not derive any benefits from CUSO ownership.

Sam Taft of Callahan worked with Jim Vilker and Bob Frizzle of CU*Answers to compare the performance of the CU*Answers credit unions with the control group credit unions from 2013 to 2019 in ten metrics: Fee Income, Other Operating Income, Share Draft Penetration, Accounts Per Member, Size of Average Member Relationship, Operating Expense Ratio, Efficiency Ratio, Return on Assets, Net Worth Growth, and Asset Growth. In every metric but one, the CU*Answers credit unions outperformed the control group credit unions and, in most cases, the difference was significant. The Operating Expense Ratio was higher for the CU*Answers credit unions but the Efficiency Ratio (the effectiveness of the spending to earn income) was higher in the CU*Answers credit unions, indicating that they are spending more but they are reaping the benefits of that spending. The specific findings can be found in the White Paper available on NACUSO's website www.nacuso.org.

We note that the CUSOs do not help credit unions, the credit union owners use CUSOs to help themselves. The CUSO is but the means for credit unions to collaboratively create options and opportunity for themselves and their members.

The data shows a strong correlation of extensive CUSO use with high credit union performance. Is the effort of forming and operating CUSOs worth it? You bet it is. If you had any doubt about using a CUSO, just do it.

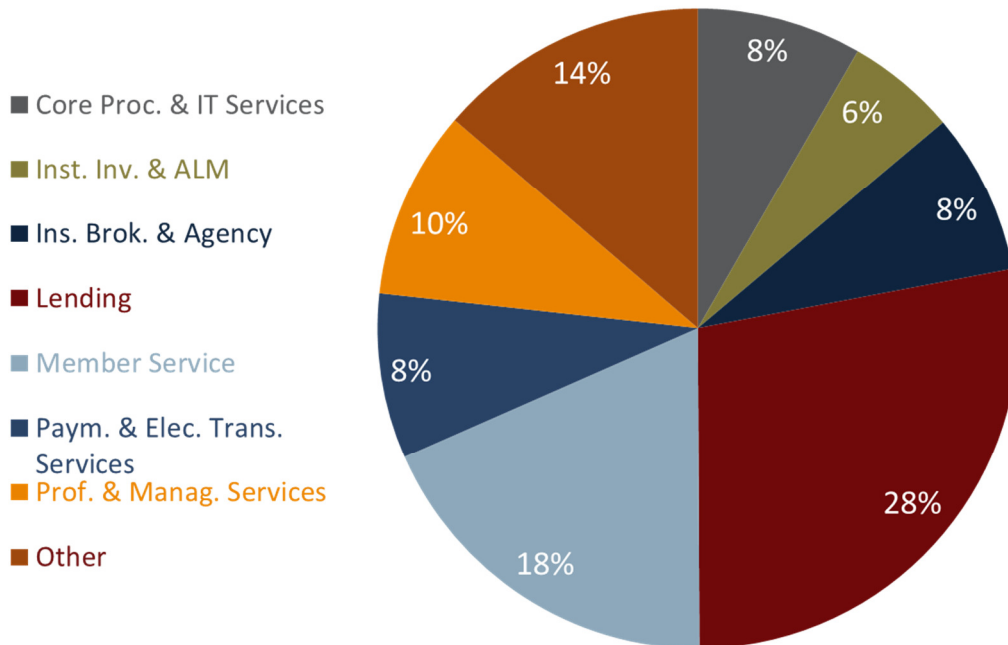

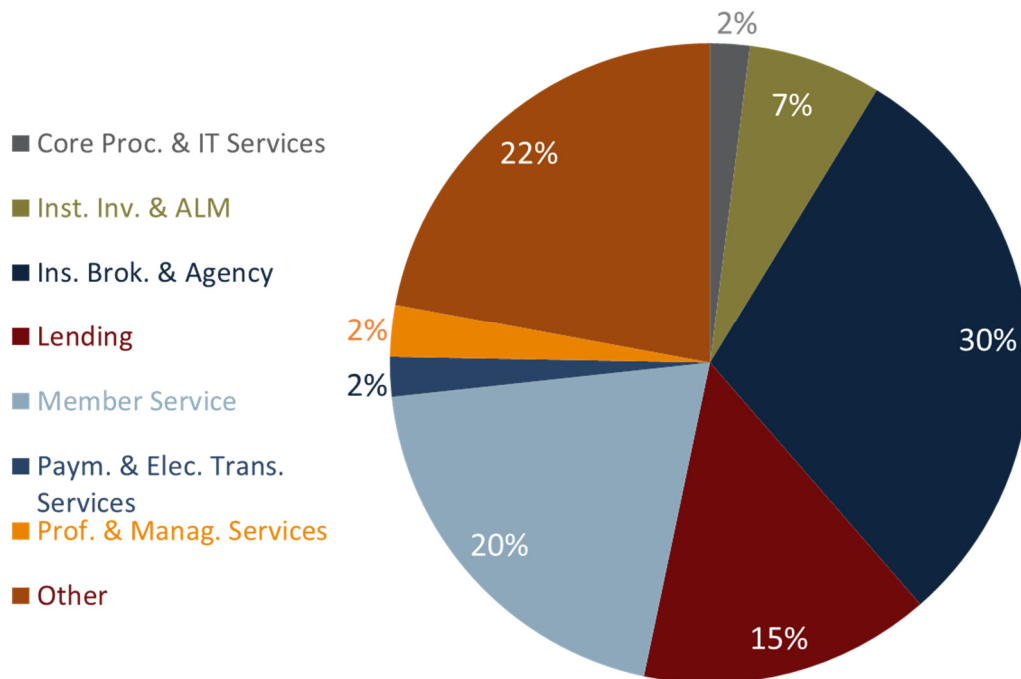

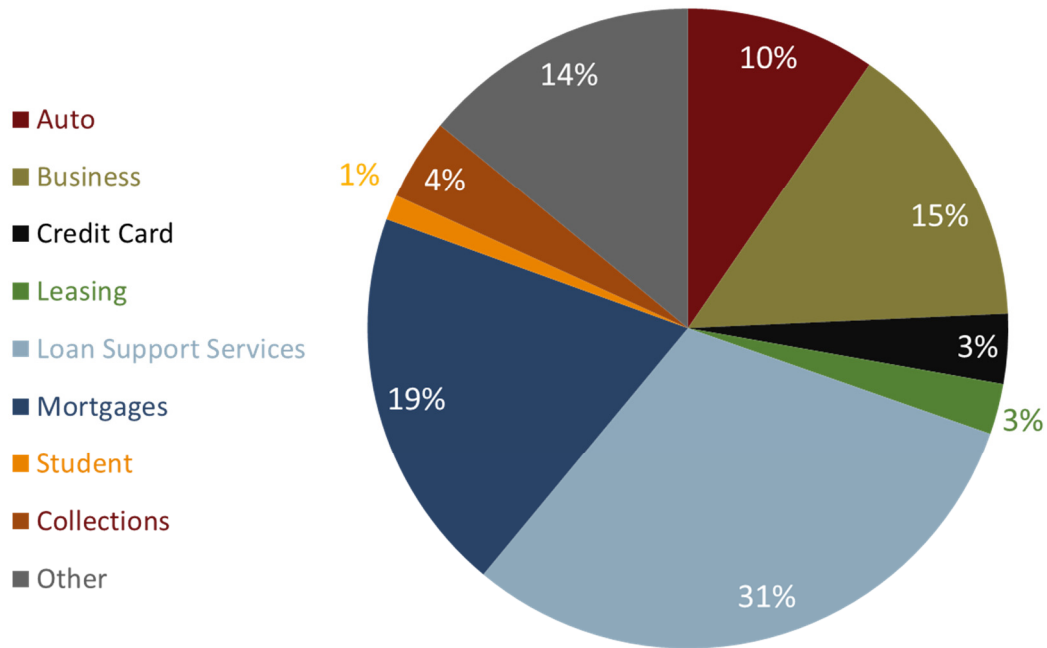

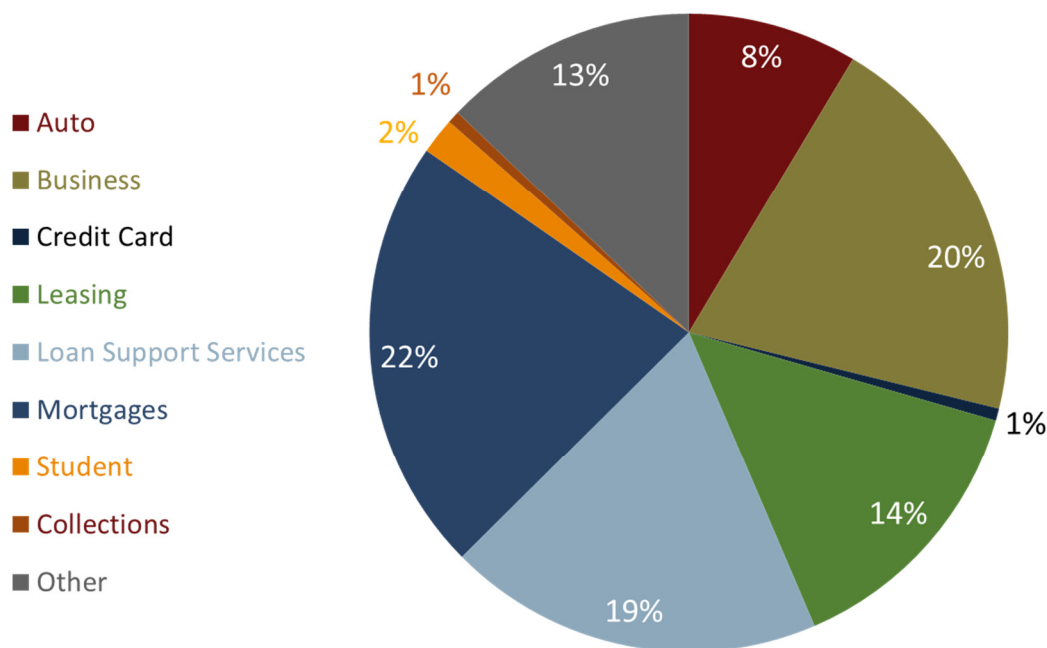

Wholly-Owned Lending Service Offerings

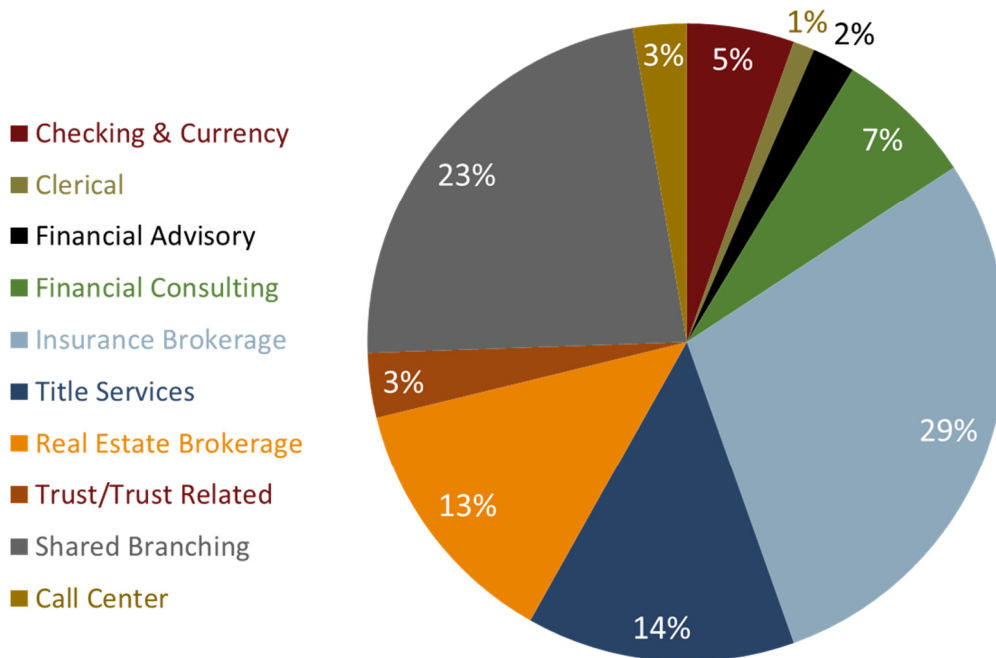

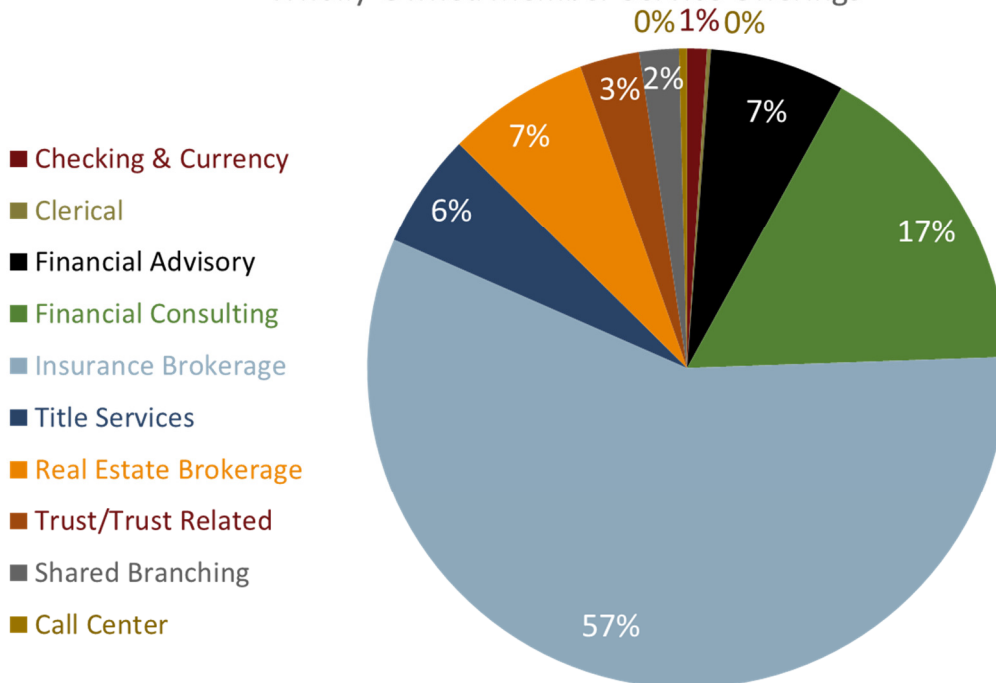

Wholly-Owned Member Service Offerings

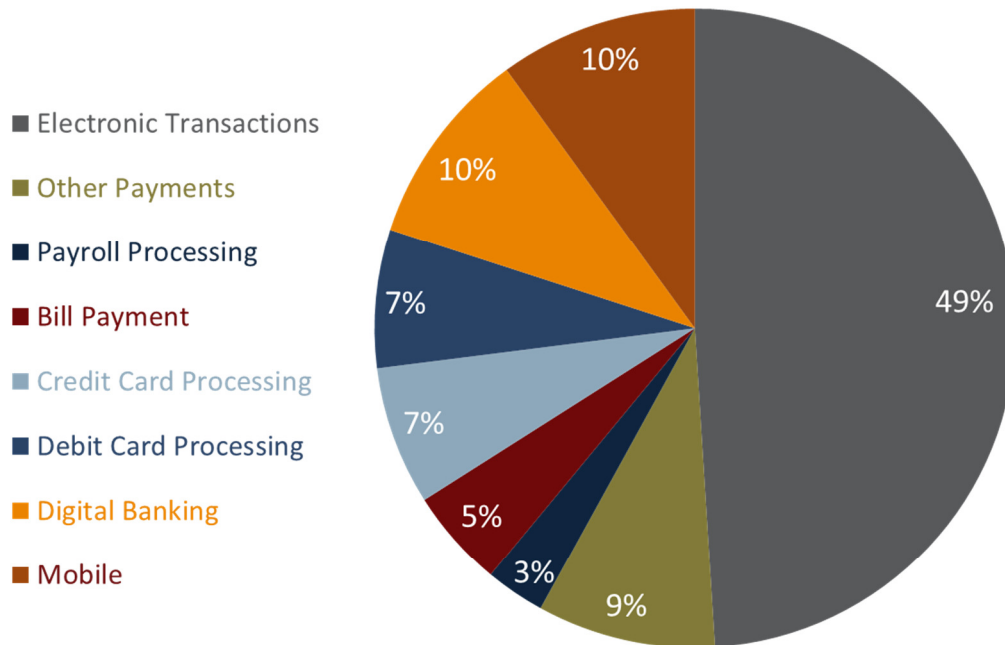

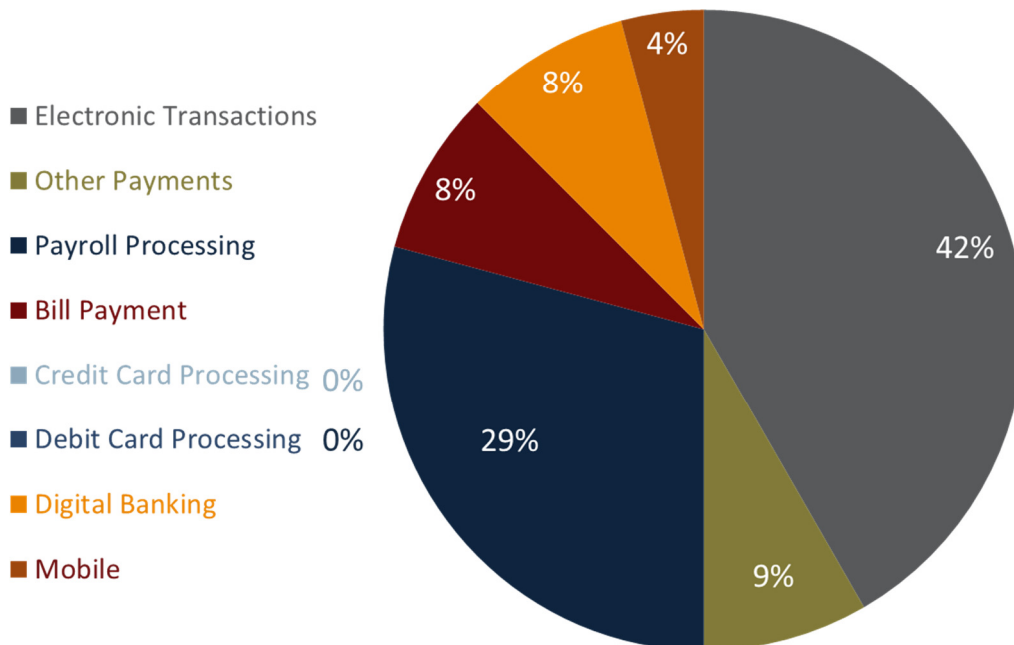

Multi-Owned Payments and Elec. Trans. Service Offerings



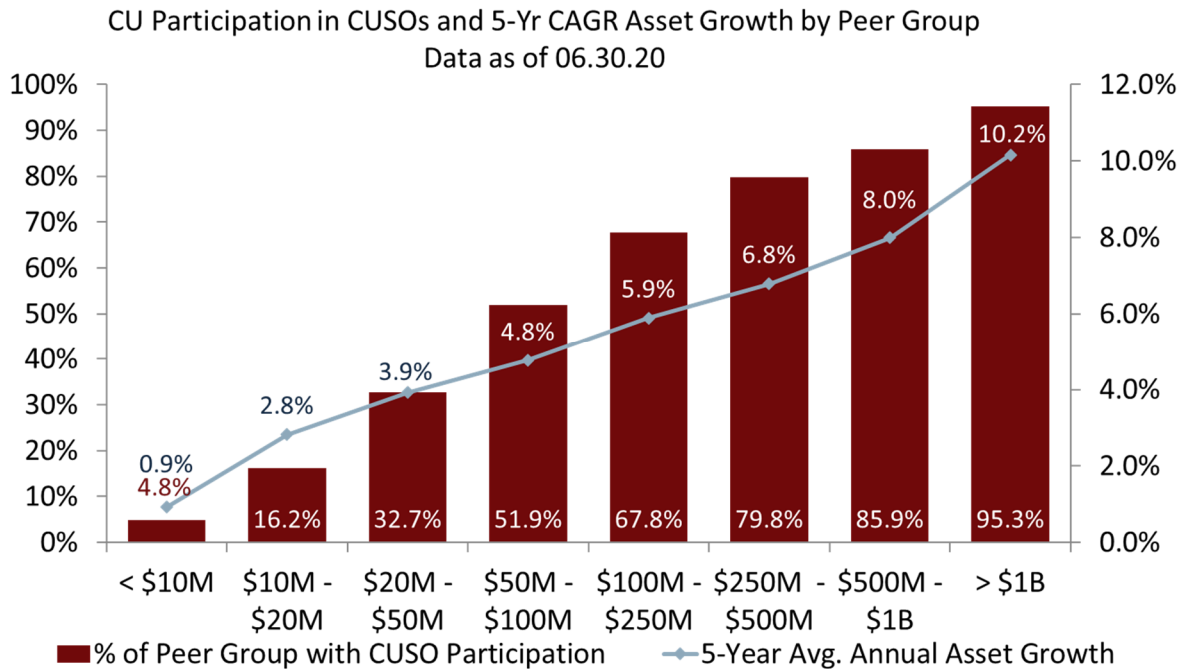
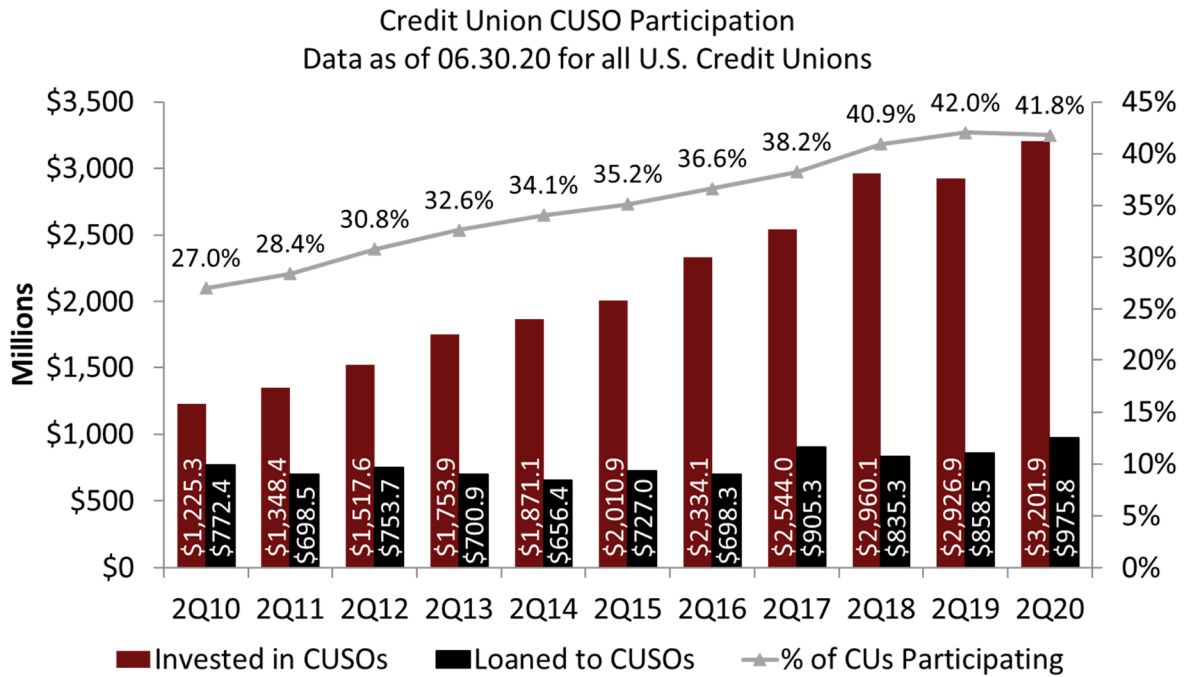

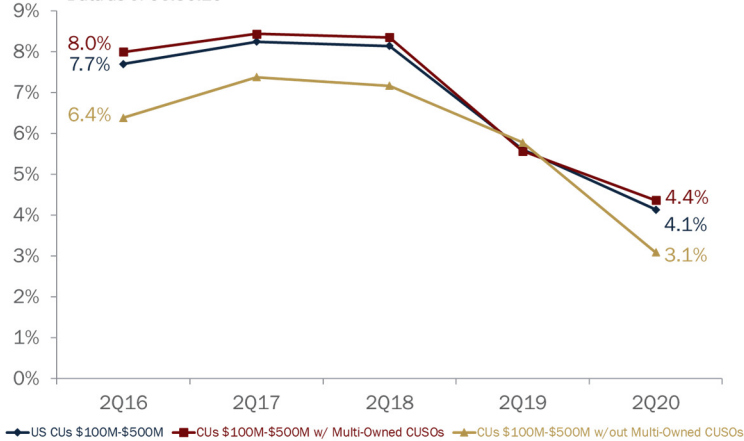


Lending Trends

- Credit unions that invest in multi-owned CUSOs reported a lower percentage of mortgage loans (30.6%) than credit unions who do not use CUSO services (35.6%). Both peer groups reported strong growth in the loan segment however, up 11.3% and 8.7%, respectively.
- As of June 2020, total loan balances increased 4.1% annually at credit unions between \$100 million and \$500 million. Credit unions that use multi-owned CUSO offerings, reported growth 0.30 percentage points higher over the period.
- Loan production increased 21.1% year-over-year at credit unions between \$100 million and \$500 million that use multi-owned CUSOs as of June 2020, compared to origination growth of 19.6% at peer credit unions without CUSO holdings.
- First mortgage funding rose 100.3% year-over-year at credit unions with multi-owned CUSO investments. Alternatively, credit unions that do not use multi-owned CUSOs, first mortgage production was up 60.0% annually.
- Despite reporting a lower concentration of mortgage loans, which tend to have lower delinquency rates, credit unions with multi-owned CUSOs reported better asset quality than their counterparts. At 0.59%, delinquency at these credit unions decreased 7 basis year-over-year, 13 basis points below the rate reported by credit unions that are not CUSO investors.

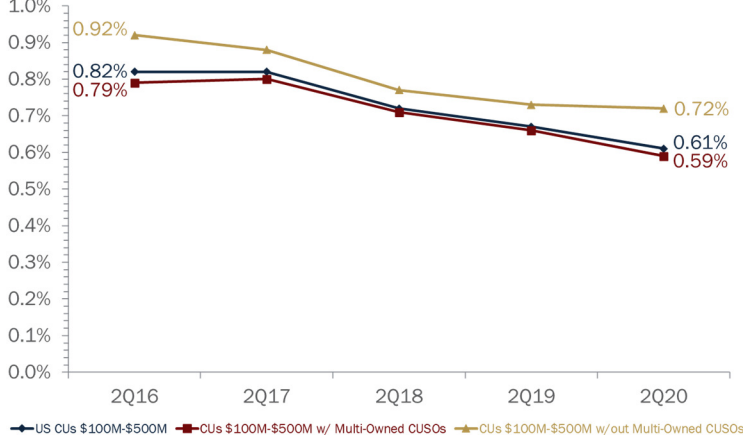
ANNUAL TOTAL LOAN GROWTH

Data as of 06.30.20



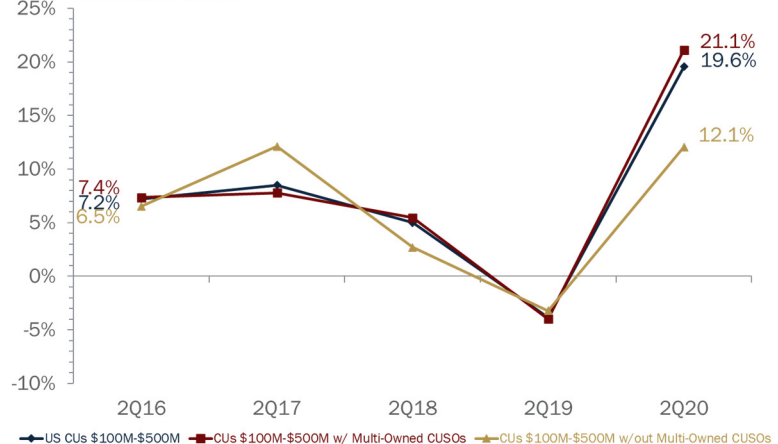
LOAN DELINQUENCY

Data as of 06.30.20



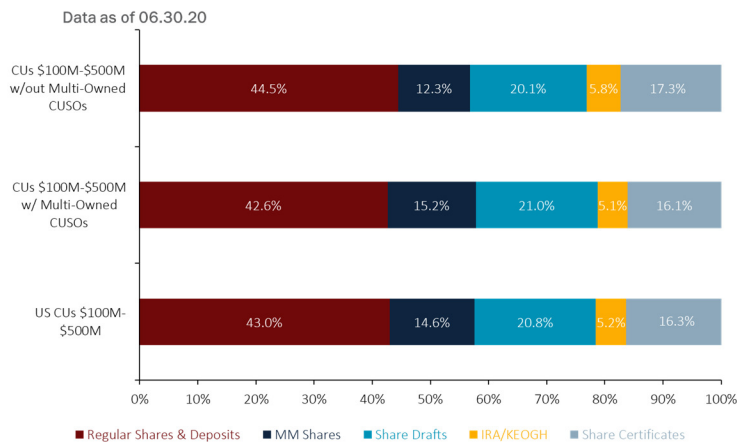
LOAN ORIGINATION GROWTH

SHARE COMPOSITION



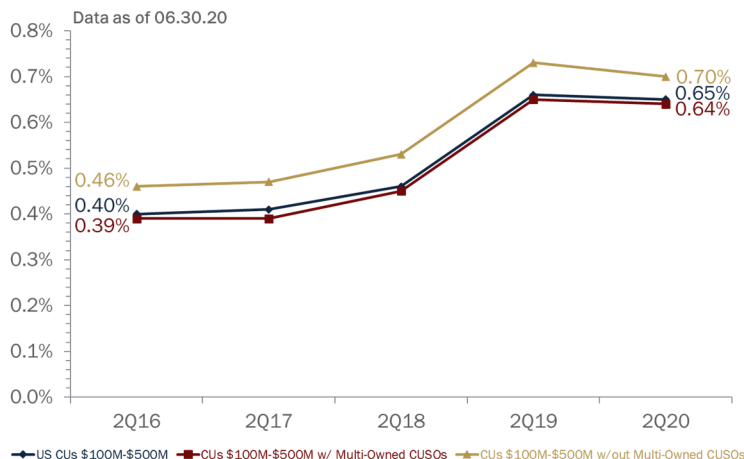
Share Trends

- Total share balances at credit unions between \$100 million and \$500 million increased 14.1% year-over-year. Credit unions in the asset range with multi-owned CUSO affiliates reported 14.4% deposit growth over the last 12 months, while those who do not reported 13.1% growth.
- Core deposits - considered “sticky” as they often infer deeper relationships with members - increased 17.0% at credit unions using multi-owned CUSO services. Core deposits make up 78.8% of the deposit portfolio at these credit unions and 76.9% at credit unions without CUSO investments.
- Low interest rates resulted in slight declines in funding costs at all peer groups. The average cost of funds for credit unions in this segment was 0.65%, down 1 basis point year-over-year. Whereas credit unions with CUSO investments also reported a 1 basis point decline over the period, their average cost of funds remained the lowest of any peer group.
- The average cost of funds is higher at credit unions between \$100 million and \$500 million that do report CUSO investments (0.70%). This is largely due to a higher concentration of certificates (17.3%) than credit unions using CUSO services (16.1%).
- The loan-to-share ratio decreased annually as of the second quarter at all peer groups. Share growth accelerated 8.7 percentage points year-over-year at credit unions in the asset band as members look for low risk savings accounts amid financial uncertainty due to the Coronavirus pandemic. Despite the decline, credit unions with CUSO investments in this asset range have consistently loaned out a larger proportion of their balance sheets than credit unions without CUSOs.

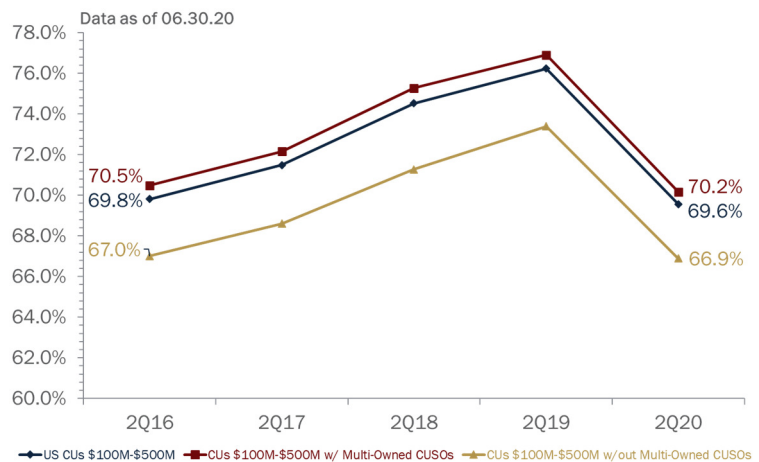
CORE DEPOSIT GROWTH



AVERAGE COST OF FUNDS

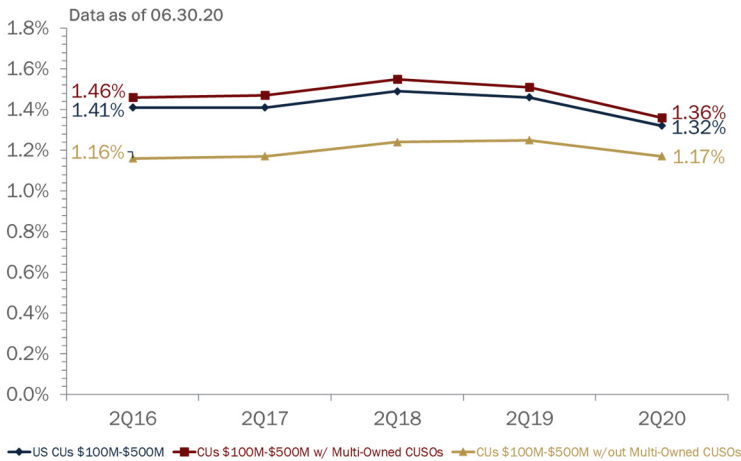


LOAN-TO-SHARE RATIO

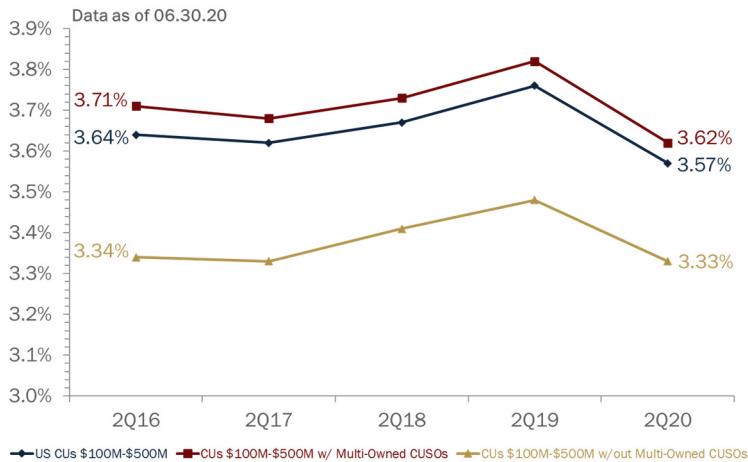

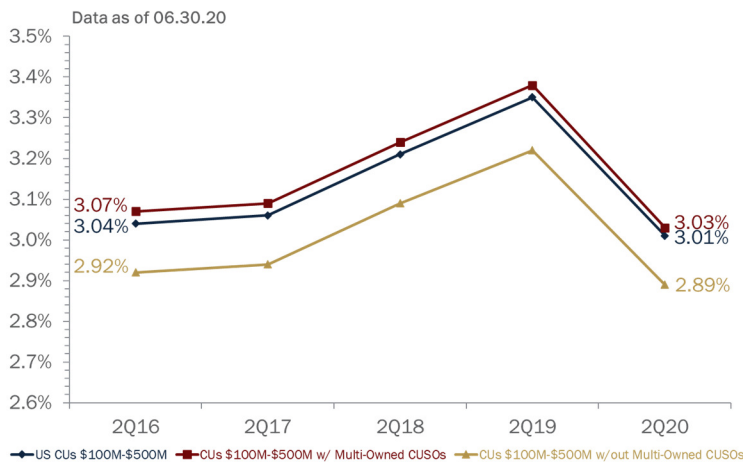
Non-Interest Income/Average Assets



Operating Expense/Average Assets



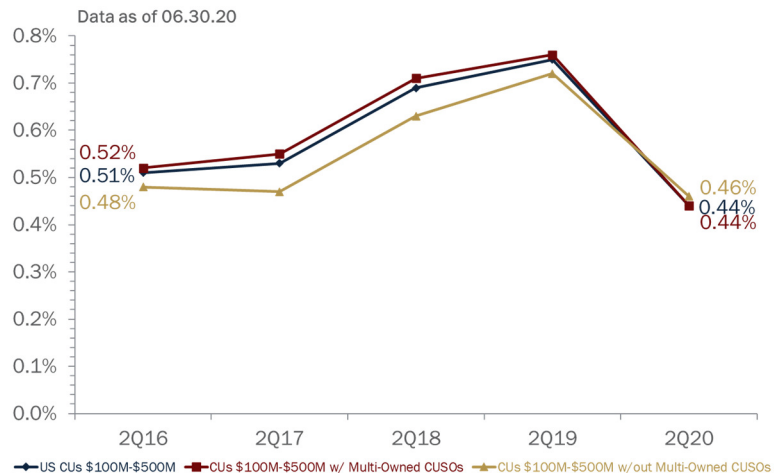
Net Interest Margin



Earnings Trends

- Total revenue at credit unions between \$100 million and \$500 million decreased 0.9% year-over-year. Interest rates were held at record lows in the hopes to encourage consumer spending, which resulted in a 0.6% decline in interest income.
- The operating expense ratio decreased at both credit unions that report CUSO investments (down 19 basis points to 3.62%) and those that do not (down 15 basis points to 3.33%). While credit unions with CUSO investments report higher operating expense ratios, historically they have found success leveraging their cost base to provide more services and generate higher income than their peers.
- Salary and benefit expenses increased 6.4% annually at credit unions between \$100 million and \$500 million in assets and account for 51.3% of total operating expenses. Credit unions that invest in CUSOs increased average salary expenditures 6.4%, 41 basis points faster than credit unions that do not.
- Credit unions between \$100 million and \$500 million in assets with CUSO investments reported an average decrease of \$13.1 million in interest income and a \$40.1 million increase in interest expense over the period. The resultant decrease in net interest income led to a 35 basis point drop in the net interest margin.
- The net interest margin at credit unions invested in CUSOs fell 35 basis points year-over-year to 3.03% as of June 2020, 14 basis points above credit unions without CUSO holdings.
- ROA decreased 31 basis point annually at credit unions between \$100 million and \$500 million in assets. At 0.44%, the rate reported by credit unions with CUSO investments is in line with asset based peers.

MEMBER RELATIONSHIPS

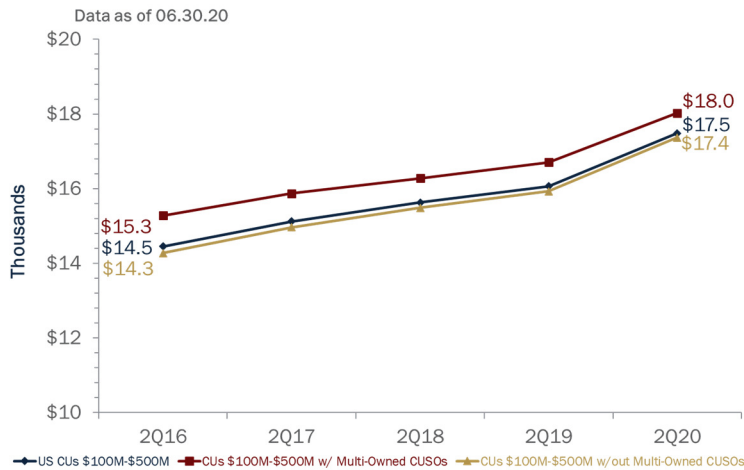
MEMBERSHIP GROWTH



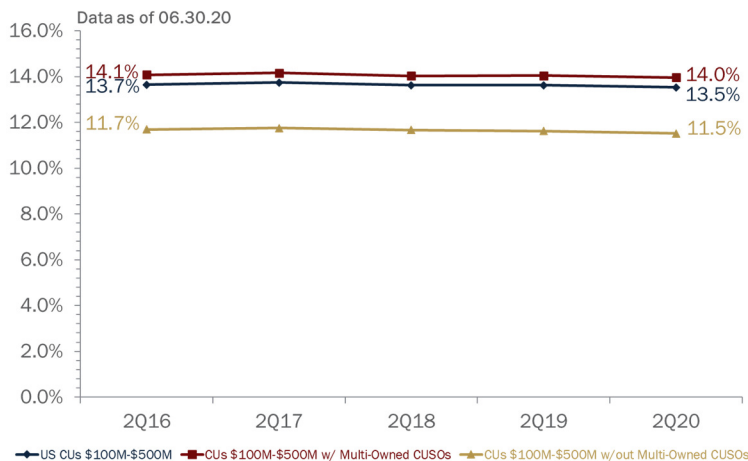
Member Relationship Trends

- Total membership increased 0.9% at credit unions between \$100 million and \$500 million in assets. Credit unions that invest in CUSOs have an average membership base of 18,892, 2,216 members higher than the average at credit unions not using CUSO services.
- Average member relationship - a measure for the average retail relationship per member - increased over \$1,400 across all credit unions between \$100 million and \$500 million in assets.
- Credit card penetration has consistently been higher at credit unions that invest in multi-owned CUSOs. At 14.0%, credit card penetration at these credit unions decreased 8 basis points annually. Similarly, credit unions that do not report CUSO investments saw a 10 basis point annual decline in credit card penetration to 11.5% as of June 2020.
- Share draft penetration, the proxy measure for the percentage of members that use the credit union as their primary financial institution, is 2.6 percentage points higher at credit unions with CUSO investments.
- Auto penetration increased 43 basis points annually at credit unions with CUSO holdings to 21.7% as of June 2020.

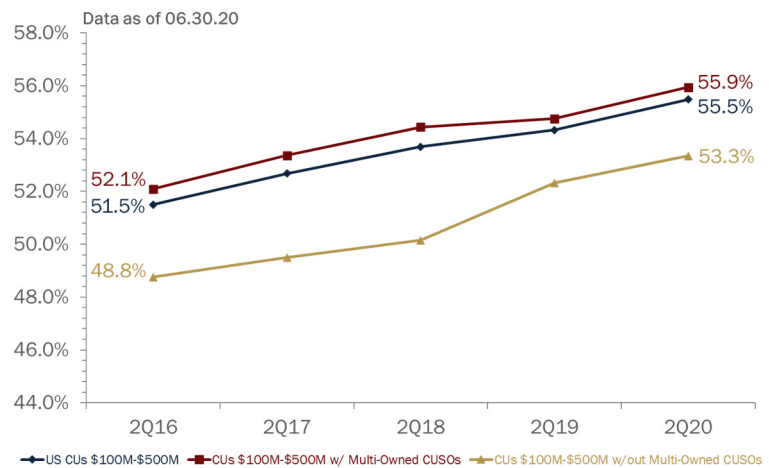
AVERAGE MEMBER RELATIONSHIP
